The Minister of the Ministry of Planning and Finance, in exercise of the powers conferred under subsection (d) of Section 3 of the Tariff Law, hereby issues this notification.

1. In order to recover the economy and support the local Micro, Small and Medium Enterprises, the tariff rates of importations, under the Semi-Knocked Down-SKD system and Completely Knocked Down-CKD system to be produced fuel used vehicles domestically with the permission of the Myanmar Investment Commission, are to be reduced as follows:
